**Subject: Submission of willingness for CBSE Class X Second Board Examination (May 2026)**

Dear Parents,

Greetings!

This is to inform you that as per the latest CBSE Circular No. CBSE/LOC/X/2025-2026 dated 17 March 2026, the Board has introduced the Second Board Examination for Class X, scheduled to be held in May 2026.

Under this policy, students who have appeared for the First Board Examination will be given an opportunity to improve their performance in up to three subjects, subject to CBSE rules and eligibility.

In order to submit the List of Candidates (LOC) to CBSE within the stipulated timeline, the school is required to collect the willingness of students/parents in advance.

### **Important Points for Parents**

1. It is mandatory for all students to have appeared for the First Board Examination.
2. Students who wish to appear for the Second Board Examination may do so only as per CBSE eligibility criteria.
3. Students who have passed Class X may apply for improvement in up to three subjects from among Science, Mathematics, Social Science, and any one Language.
4. Students placed in the Compartment Category may also be eligible under CBSE norms.
5. If a student has not appeared in 3 or more subjects in the First Board Examination, he/she will not be eligible for the Second Board Examination.
6. No new names can be added later to the LOC for the Second Examination. Therefore, parents are advised to submit the willingness carefully and within the given time.
7. No correction in student data from the First Examination to the Second Examination will be permitted by CBSE.
8. No change of examination centre will be allowed once allotted by CBSE. Also, the examination centre may not necessarily be near the school/home, as centres may be limited.
9. There is no provision for improvement in Internal Assessment, as it is a year-long component.
10. Students who may wish to avail of this opportunity for any reason are strongly advised to submit their willingness in advance so that the school can complete the LOC submission on time.
11. Students who have appeared for Mathematics Standard in the First Board Examination cannot appear for Mathematics Basic in the Second Board Examination and vice-versa.

Please note: Submission of this form is mandatory for all Class X students, so that the school can maintain accurate records for LOC submission.

This form is being collected in advance as per CBSE instructions for LOC submission. Final appearance in the Second Board Examination will remain subject to CBSE eligibility rules, declaration of First Board Examination result, and payment of applicable CBSE examination fee (as per Board schedule).

Subject: Submission of List of Candidates (LOC) for Class X Second Board Examination – 2026

Madam/Sir,

As per the recommendations of NEP 2020, CBSE has introduced the **Two Board Examination Policy**, notified on 25 June 2025. Under this policy, Class X students will be given an opportunity to improve their performance in up to **three subjects** during the **Second Board Examinations** scheduled in **May 2026**.

2. This circular explains all the action needed to be taken by schools for the submission of the LOC for the Second Board Examinations. Principals are requested to go through the instructions mentioned and initiate action accordingly for timely submission of LOC for the Class X Second Board Examinations 2026.

### 3. How to proceed for LOC submission

LOC will be submitted by the schools for all desirous students. As for the first time, CBSE will hold the Second Board Examinations in Class X, hence, to know the correct figure of students who wish to appear in the Second Board Examinations and to also to know the subjects in which they wish to appear, CBSE has decided to make the schedule of submission of LOC in such a manner that all required information is available with the CBSE in advance to make the foolproof preparations of the examination.

<b>LOC Submission- 3<sup>rd</sup> Phase with late fee</b>	7 <sup>th</sup> day from the day of declaration of results for 2 days
<b>Examination Fee payment- 3<sup>rd</sup> Phase with late fee</b>	7 <sup>th</sup> day from the day of declaration of results for 2 days

Lines will be opened till 11.59.59 PM on last working day as per schedule given above.

#### **4. Expectation from the Principals**

The following are expected from the Principal of the schools to the students and their parents:-

- (a). be guided about rules of Second Board Examinations and use of this facility only in dire need.
- (b) be informed about the eligibility criteria and the schedule of submission and payment of fee.
- (c) be informed that as examination centres would be limited in number, hence, their examination centre might not be nearer.
- (d) no examination centre will be changed once allotted.
- (e) be advised that who so ever wishes to appear in the Second Board Examination because of any reason, they should submit LOC during 1<sup>st</sup> phase as this will help CBSE in the advanced preparation. However, students can decide finally based on the declaration of result and then pay the examination fee. Students who decide based on their result may submit both LOC and the examination fee during 2<sup>nd</sup> phase.
- (f) Candidates appeared in the main examinations and placed in compartment, such candidates need to re-submit their LOC afresh as their improvement subject criteria might change.



- (g) Students from the Middle East countries where examinations have been cancelled, they can submit their LOC after declaration of result in 2<sup>nd</sup> phase.

### **5. Condition to appear in Second Board Examinations**

- (a). It is mandatory for all the students to appear in the first Board examination.
- (b). All passed and eligible students are allowed to improve their performance in any of the three subjects out of Science, Mathematics, Social Science and languages.
- (c). If a student has not appeared in 3 or more subjects in first examination, then s/he is not eligible to appear in the 2<sup>nd</sup> examination. Such students are allowed to appear in the main examination only next year in the month of February. Accordingly, they will not be able to submit LOC.
- (d). For students whose result in the first examination is Compartment, such students are allowed to appear in second examination under Compartment Category.
- (e). No new names will be added to the LOC of the 2<sup>nd</sup> examination.
- (f). Subject change is not allowed from first examination to second examinations except permitted as per policy in case of Mathematics.
- (g). No correction in the student's data from first examination to second examination is allowed.
- (h). Candidates who were registered as CWSN candidate in the first examination will only be extended facilities as provided by the CBSE. No new candidate is allowed under CWSN category in the Second Board Examinations.



## **6. Improvement in Internal Assessment**

There is no facility of improvement of performance in internal assessment as it is a yearlong exercise.

## **7. Eligibility Criteria for Appearing in the Second Board Examinations**

The eligibility to appear in the second examination is as follows:

- (a) a student must have appeared in at least 3 examinations in the first Examinations,
- (b) Must have pass Class X for appearing in improvement
- (c) Placed in compartment category.
- (d) Passed Class X by replacing with the 6<sup>th</sup> subject.
- (e) Students placed under UFM category 1 (if otherwise eligible).
- (f) Students placed in Compartment category in 2025 examinations.
- (g) Any student who has not appeared in 03 or more subjects in the 2026 Main examination is not eligible for the Second Board Examination.
- (h) Improvement category up to 3 main subjects out of Science, Mathematics, Social Science and language
- (i) First/Third Chance Compartment
- (j) Compartment + Improvement
- (k) Improvement for the students passed by the replacement of the subject.
- (l) Sports students who were given permission by the Board.
- (m) If a student has not appeared because of any reasons/ failed in 3 or more subjects in the First Examination then he/she is not eligible to appear for the Second Board Examinations.
- (n) Students placed in the ER category are not eligible for the Second Board Examinations. They are allowed next year in the main examinations.

## **8. Syllabus and Scheme of Examinations**

The Second Board Examination will be conducted on the syllabus of first examination meant for the year.

Rest of the instructions will remain the same as per the circular of LOC for the main/first examinations and the two examination policy.

**Important Note:** The fee will be accepted in the online mode only prescribed by the CBSE. No fee in offline mode, direct deposit in the bank account etc. will be accepted. The offline fee deposited by school/candidate shall not be updated in the school accounts and LOC shall not be accepted.

<b>FEE PAYMENT METHOD</b>	
(A)	Fees for all activities are accepted only through the following digital payments modes by CBSE: India: - Debit Card/Credit Card/UPI/Net banking Other Countries including Nepal: - Debit Card/Credit Card/SWIFT
(B)	Before payment of the fee, schools can take the print of LOC in the form of checklist. Once fee is paid, the final LOC will be printed, and no correction could be made in the online or offline mode thereafter.
(C)	As SWIFT updating may take 2-3 days, hence, schools situated outside India are advised to complete their process including payment of the fee in such a way that their process is over before the last date.

(D)	<p>In case of Bank related transactions or non-updating of fees on the CBSE server, the schools should contact the respective Bank through which payment was made. Contact details of Banks are given on the CBSE website. Generally, Bank shall be requiring the following information to resolve the issue of non-updating of fees hence, be kept ready before getting in touch with the Bank:</p> <ul style="list-style-type: none"> <li>(i) Mode of payment</li> <li>(ii) Fee Reference No.</li> <li>(iii) Amount deposited</li> <li>(iv) Date of deposit</li> <li>(v) Branch where amount was deposited</li> <li>(vi) Bank reference number (Transaction ID as reflected in Bank Account)</li> <li>(vii) Your contact number.</li> </ul>
<b>ILLUSTRATION FOR CALCULATING LATE FEE</b>	
	The date on which the data is finalized is taken into account for fee calculation
(i)	If students' details are entered and finalized on or before the last date, the school can pay fee till last date without late fee. Thereafter, late fee shall be applicable.
(ii)	It may be noted that if LOC data of students is not finalized by the last date, late fee will be applicable. No extension of last date will be given after the finalization of data. The finalization of data is an activity subsequent to entry/upload of students' data.
(iii)	<b>Caution:</b> The schools shall ensure that LOC data is finalized in time and fees should be deposited strictly as per schedule. Any delay in in finalization of LOC data and depositing fee shall attract late fee penalty as given above.
